The breeder guarantees the above described dog to be healthy at the time of the sale. The breeder does not assume any liability for any injuries made to puppy after delivery due to the negligence of the buyer.

The buyer agrees to have this puppy examined by a veterinarian within 72 hours of delivery. If the puppy is to be found in poor health within the 72 hour time frame breeder must be notified immediately. If the buyer chooses not to have puppy examined within 72 hours this contract will become null and void for any refund of monies or replacement puppy.

The buyer must present to the breeder written verification from veterinarian as to the illness of the puppy prior to refund. No refund will be made until such documentation is provided. Breeder reserves the right to take said puppy to his vet for a second opinion before any refunds are made.

The buyer agrees that all documents that were submitted at the time of sale be returned to breeder upon return of said puppy. If not returned buyer will not receive purchase price of dog.

All vet charges and expenses will be paid by the buyer. Seller will not be responsible for any vet bills incurred.

Breeder provides a two (2) year genetic health guarantee. Should the puppy expire within the first 2 years of life **DUE TO A GENETIC DEFECT CAUSED BY THE BREEDER**, BREEDER will replace the puppy. Also if the puppy has a Vet certified genetic health defect that does not cause death the seller will also make a refund to buyer. The refund of purchase price or exchange of a puppy will only happen under the following conditions:

1. Buyer agrees that should puppy expire for unknown reasons and the buyer requests another puppy that an autopsy should be preformed on the puppy and a written statement is to be provided to the breeder with the exact cause of death at the buyers expense. There will be no cost except shipping or with approval of breeder and purchaser monies may be refunded.
 2. If the puppy is found to have life threatening genetic problem due to the breeder within the first two years of life then a replacement puppy or monies will be provided upon written proof from veterinarian with EXACT cause of illness. Puppy will be shipped back to breeder at buyers expense.

3. Buyer agrees to return any registration papers from previous puppy to breeder before providing replacement puppy.

This puppy is sold on a spay/neuter contract. He or she has not been sold for breeding purposes. All registration papers will be released by AKC , once they confirm spay/neuter has been performed. This document constitutes the entire agreement between the breeder and buyer with respect to this sale. The purchaser's signature below signifies that they have read and understand all the conditions of the sales agreement and contract of sale.
